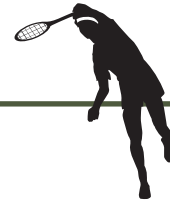

ANSWER You would have lost the bet in 2003 but you win the bet in 2004!!

Tennis code #26:

Neither the server nor server's partner shall make a fault call on the first service even if they think it is out because the receiver may be giving the server the benefit of the doubt. (added to the code this year is the following) There is one exception. If the receiver plays a first service that is a fault and does not put the return in play, the server or the server's partner may make the fault call. (the rest is from last year) The server and the server's partner shall call out any second serve that either clearly sees out.

The USA Spring Mixed Doubles League teams have been formed and matches will start April 18. Other league deadlines for getting all fees to League Coordinators to register a team are fast approaching:

USA Adult League: deadline of April 6 minimum of 8 players

CTA Super Senior League (60+): deadline of April 9 minimum of 6 players

CTA Women's Daytime Doubles League: deadline of April 29 minimum of 6 players

World Team Tennis: deadline of June 25 minimum of 4 players

World Team Tennis is a new outdoor league for Colorado. It has different rules and a different format. Six fast-paced sets are played in a combination of Men's and Women's Doubles, Men's and Women's Singles and Mixed Doubles, using no-ad scoring and tiebreaks to 5 (no-ad) at 5 games all in a set. Substitutions are allowed and let serves are played. You do not have to be a USTA member to play in this league. Play will be on Sundays at 1 pm, starting June 13. Fee will be \$26/person. Give this new league a try. It is a very social event with cheering and coaching allowed from the sidelines.
