### SATURDAY, JUNE 19TH CENTENNIAL MIDDLE SCHOOL COURTS

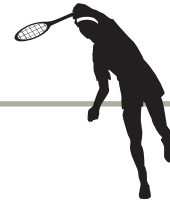

*My opponent and I were warming up our serves before a match. As I was hitting my warm-up serves, my opponent returned them as hard as he could, hitting down the line and cross court returns. I informed him that he could either catch the ball and hit his own serve or return the ball directly to me. He said that he was just practicing his return of service. What does the code say? -P.P.*

**ANSWER** The code states "Warm up is not practice. Some players confuse warm-up and practice. A player should make a special effort to hit shots directly to the opponent. Courtesy dictates that you not practice your service return when your opponent practices serving. If a player has completed the player's warm-up serves, the player shall return warm-up serves directly to the opponent.

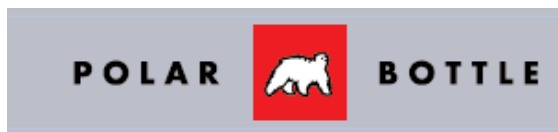
